## **Constitution Day**

Constitution Day is observed every year on September 17<sup>th</sup>. It allows citizens to learn more about their rights and responsibilities. It is not a public holiday.

Constitution Day commemorates the formation of the United States Constitution. On September 17<sup>th</sup>, 1787, 39 out of 55 delegates signed the document. The Constitutional Convention was held in Philadelphia. This was four years after American gained its independence from Britain. It was one of the most critical events. It formed a strong central government with three separate branches and gave us our individual rights.

The signing of the Constitution on this day formed a basis for the rule of law, the balance of power, and enduring principles that built the United States. Our Constitution is the oldest in the world and is considered one of America's most important documents.

Constitution Day is celebrated in many ways. The President of the United States may proclaim the day and have flags displayed on all federal buildings. Individuals can also proudly display their flags showing their national pride.

Constitution Day encourages a sense of civic pride, unity, and appreciation for the fundamental principles that shape the United States. It is a reminder of the significance of the Constitution and its impact on the lives of the citizens of our nation.

### ATTENTION: SWITCH & SAVE INCENTIVE



MRSPA has extended an invitation to cash members to switch to dues deduction for 2025-2026. If they make the change, they are eligible for a one-time \$10 reduction in state dues. They would pay \$40 for state dues for 2025-2026, plus their local dues amount. Members need to complete and return the 2025-2026 Dues Deduction Authorization Form, which is available on the MRSPA website under "Switch and Save" (<a href="https://www.mrspa.org/switch-and-save">https://www.mrspa.org/switch-and-save</a>). Current Cash dues payers, who have not yet paid their dues, would be eligible for "Switch and Save".
